

**Minutes of the BCCA Annual General Meeting, Held at Wycombe & Hazlemere Club,  
Hazlemere Community Centre, Rose Avenue, Hazlemere,  
on Monday, 23<sup>rd</sup> May 2011**

**2. Present**

**3. Previous Minutes**

Last year's minutes were approved without amendment

**4. Matters Arising – County President**

The illness of our President, Alex Niedzwiedzki, had been discussed at the last AGM. Sadly he died in February and Andrew Hill and Fred Day had attended his funeral in Walsingham. At the subsequent Executive meeting, it had been agreed to invite George Parker, our former long serving Chairman, to serve in Alex's stead.

In accepting the invitation, George paid tribute to Alex's work for chess, and said that he would like to continue the tradition of the President's prize, initiated by Alex.

The Chairman was concerned that there might not be adequate space on the league shield to add a name plate commemorating Alex, as he had proposed at the Exec meeting – to be reviewed later.

**5. Officers' Reports**

**a) Treasurer**

Carl Weaver had circulated the accounts, which showed surpluses on all competitions, totalling £158, and increasing our funds at the bank and building society to £1826. In the light of that, and assuming a similar pattern of events and player numbers next season (2011-12), he considered that there need be no changes in fees or prize monies next season, despite the increase in the ECF game fee from £0.54 to £0.58. The accounts, audited by Joan Gardner, were unanimously accepted, and the meeting concurred with Carl's status quo proposals without objection.

Carl pointed out that a radical review of our competition entry fees and prize monies would be necessary for the 2012-13 season, assuming that the ECF membership scheme replaced game fees. (See further discussion on this topic under item 8).

**b) Secretary/Individual Competition/Chilterns League**

The Secretary congratulated Eugene Bolduc on winning the top section of the Individual Competition, and the Chairman presented his winner's cheque. Tim Jones was not present to receive his Div 3 winner's cheque.

Fred was disappointed that games had not been completed in Div 2, so that the winner was not yet certain, though Narinder Singh was the front runner. He had introduced provisional rules potentially penalising the laggards, and was considering adding a version of these to Schedule 2 of the constitution, as a deterrent to undue delays (Current tables on website).

Fred had attended the recent Chilterns League Exec meeting with Andrew Hill, when the following main decisions were made:

- Under 200 section will be “open” next season
- Time control will be all moves in 2 hours (“default position”), but captains may agree to play with an intermediate time control of 36 moves in 90 minutes.
- Counties to seek opinions re such time controls (see Bucks survey below).
- The Jamboree, won this year by Bucks with 12.5 points, may become a season opener in September. Venue: Oxfordshire, date: to be advised.

#### c) Club Competition Controller

Jon Melsom congratulated Wycombe & Hazlemere, on winning the championship, and also Slough first team on their return to the championship section, where they would replace Bourne End 2, who were relegated (see final tables on website).

Some 125 players had played in league matches this season. There had been no significant disciplinary problems, and defaults had been lower, except for Slough, where falling membership and accommodation issues had caused concern at the end of 2010. He expressed concern at the very late submission of results by some clubs and urged prompt reporting.

#### d) County Match Captains' Reports

The Chilterns League tables were presented and the captains reports had been circulated and considered at the Executive meeting.

*(Secretary's Note: Brian Hicks has reported since the meeting that Brian Lacey has taken responsibility for the time being for Rosetti Hall bookings for County matches, the previous contact having left – he would need to be contacted as soon as the new Chilterns fixture list is available)*

#### e) Grading Officer/Webmaster.

Dave Turner reported the the number of graded games had again increased slightly. He reiterated his Exec report reminding individuals, clubs and competition organisers that the closing date for submission of results for grading was 31<sup>st</sup> May. To ensure clear player identification, he emphasised the need for accurately-spelled full names for new players, an indication of their previous clubs, if any, gender, and birth dates for those under 18.

Dave added that consideration was being given by the ECF to issuing a second grading list halfway through next season, the update to include the new season's results. He echoed Jon's request, therefore, that all results should be submitted promptly, and he was considering the practicalities of team captains, or nominated individuals, accessing the website to enter results directly.

#### f) **Junior Chess**

Hans Hansen's report had been circulated in the Exec minutes. Since that meeting a very successful "Mega-Final" for different age groups in the 7 to 18 age range had been attended by 150 juniors at Wycombe High School

#### **2. Constitution/Rules**

No formal changes planned, but Fred's comments re possible penalties for delaying the individual competition playing schedule were noted.

#### **3. President's Prize**

Hans Hansen accepted this year's President's Prize on behalf of his son, William Claridge-Hansen, in recognition of his outstanding performances at junior national and international level.

#### **4. Best Game Prize**

Nick said that seven games were under consideration, and he hoped to inform the winner shortly.

#### **5. ECF/SCCU Matters**

Neville Belinfante's report on the ECF Finance Committee's recommendations had been circulated, the main recommendations being that the game fee for next season will be £0.58, and that game fees should be replaced in the 2012- 13 season by a Membership scheme.

In the ensuing discussion, it was pointed out that there was much detail to be resolved by the ECF before the membership scheme can be implemented, including how and when the fees would be collected, and what would happen to ECF finances and also the grading system if significant numbers failed to become members.

It was hoped that these questions and other uncertainties would be resolved at the AGM of the ECF in October. It was agreed that an earlier than usual BCCA Executive meeting should be called afterwards to consider the implications for our own competition entry fees etc.

It was noted that in a survey of Bucks players, a majority of members had continued to express a preference for the game fee system, but none had indicated that they would refuse to join the ECF. It was accepted that the responses were largely from regular players, rather than the occasional club members.
